SW Water will be submitting a planning application regarding improvements to the sewerage treatment works

Response received from Allison Homes to say that there will not be a fence around the attenuation pond, I am still waiting to hear back about the life preserver. They are happy to take the Hornbeam to plant on the site.

I have spoken to TDC and they confirmed that they had received the emails with these letters.

I spoke to DCC Highways regarding potholes, the Parish Council are not able to do anything about reporting potholes any more than an individual person. They asked if before reporting a pothole the website is checked and if the pothole has already been reported there is no need to report it again. They were aware of the road problems to Dinworthy, whilst on the phone I personally reported the road past the Moor and the road from Mill Farm to Stowford Cross. **Clir Morrish** discussed potholes – priority has been given to A and B roads by the Council. Leader and Chief Executive met a number of businesses on Holsworthy Industrial Estate, went to Shebbear to look at the river and how it is effecting land and the road. They drove around the areas seeing the problems with the roads £6.3million given by the Government recently. Part of the problem is the roads not built for the traffic. There are 2 teams out re Devolution – bringing money and a bit of power to County Hall Plymouth were originally part of the deal but they have decided to go on their own.7 communications 1 on ambulance availability and 1 on domestic violence.
