further her discussions were held about the parking situation
I received a phone call to complain about children playing with bikes on the grass at the
front of Tuckers Park damaging the grass, Cllr Holloway went to look and found no
damage had been done. I spoke to Westward Housing, they were only concerned about
the trees and if the ground is wet as it churns up the grass.
Repairs to the play equipment can be done by any maintenance person who is
competent. The swing timbers need to be replace so additional help will be needed.
I contacted Allison Homes and they are organising the clearance of the storage area.
The bench on the green has been repaired.
Cllr SL has been repaid for the flowers that she had bought this money was coming from
the grant money from Cllr Dart and the Chair's allowance
A parishioner had asked if a speed activated sign could be installed by Cleverdon Close –
the costs were discussed and speed watch would need to prove that cars are speeding
Issuing a newsletter might attract volunteers for speed watch and other things
The tractor has been looked at for advice and it was thought that it could be repaired
