5. Chairman's Report:

On Wednesday 23rd July I attended an Engagement briefing from TDC re: Local Government Reorganisation (LGR). The government's English Devolution White Paper, Power and Partnership: Foundations for Growth states that all the remaining two-tier area in England to be eventually restructured into single-tier unitary authorities.

To be a Unitary Council you need 500k residents as a guiding principle.

Devon – 800k

Torbay - 1,400

Plymouth – 2,600

Cornwall - 5,700

Local leaders were then asked to work together to develop robust and sustainable unitary proposals that are in the best interests of the whole area. They have to consider functional economic areas, travel to work areas. They have until 28th November 2025.

Efficiencies should be identified making sure the taxpayer gets the best possible value for their money. The timeline from submitting proposals to 'vesting day' is approximately two and half years. So, it should go live 2028 when there will be local

elections.

The proposal at the moment is to combine East, Mid and North Devon alongside Torridge and the City of Exeter (approx. 546,000). The other unitary options would be West Devon, South Hams, Teignbridge and Torbay (426,000). Lastly Plymouth wants to remain as a stand-alone unitary authority.

Council Tax and business tax has to be taken into consideration as well as children's services, adult services and highways which now is dealt with by Devon County Council. They are still waiting data from DCC concerning costs.

There is a Council Leaders Board Decision Making Group and Cllr Ken James is representing Torridge. Thursday 24th July, I attended The Torridge Collaborative meeting at Langtree with Cllr Ken James as one speaker and a representative from DALC as the other.

Ken James told us about the Reorganisation which I had heard to the day before, but it never hurts to hear it again, as there are bits you miss.

What did occur to me was the enormous amount of work going into this project but also trying to carry out normal business. Plus, it seems that we will no longer have district councillors and parish councils are not mentioned in the White Paper. There is talk of Community Committees but there is no evidence to support this.

The representative from DALC explained that there focus now is to help parish councils prepare for this and are sending out newsletters. There is also a survey on their website they would like us to complete.

I went to Mole Valley yesterday and talked to them 3-4 farms in this area are in the process of shutting down. In the Telegraph 1^{st half of this year} 1800 agricultural businesses closed only 800new ones opened therefore a loss of 1000 this is a real worry, we are trying to give support people as much as we can.

First responders meeting had a mixed response – it was decided that it should be put on hold until there is more information – concerns will volunteers have the training and equipment they need, can they respond as quickly, will there be enough of them. It is a big issue in such rural areas, it will be looked at again 7.8.25

Cllr SH stated that fire stations will be closed if not needed, first responders are so important for speed and knowledge of the area.

Report of meeting with Sandra Brown – TDC Highways

Attended: Cllrs. Greatorex, Chapman, Lander

We walked around the village to show SB the problems.

Signage removed belonging to Torridge. SB informed Southwest Water to remove theirs. SB said that in future if we have the same problem then look on the back of the sign and if there is a phone number, telephone them, and ask them to remove it. If blank on the back, then it probably belongs to Torridge and inform Highways.

We asked if we could have yellow lines outside the doctors' surgery on North Road, but SB said without enforcement it would be pointless.

SB sprayed the potholes in the Square to indicate they needed to be repaired.

SB has reported that all white road lines to be repainted including exits from the Square and Langdon Road.

SB will contact Nigel Flower regarding parking by the school. SB said this is a problem for most schools but Nigel Flower may have a solution.

We walked to the Sutcombe road junction to show SB the problem. She said that parking by a junction is not illegal but only advisory. You are advised not to park at a junction.

We informed SB about the problems of parking outside the post office, but nothing really can be done about it.

SB noted the mirror near Broadhill. It might be removed as TDC cannot take responsibility for any injury it may cause. Although she did understand why it was put there.

She noted the parking around Broadhill but again nothing can be done.

SB looked at the verge opposite Bromells. If it is to be reduced, it won't happen until the Autumn.

Apparently not a priority though Moor road to Woolsery. SB has driven down it. We explained that it is the main route to Woolsery and the people of Woolsery use it when visiting the doctors' surgery. She said she would try to video it. She said it would go on the list but probably not in this financial year.

We walked down to look at the road opposite Baily's farm. SB took photos.

SB also took photos of the state of the road outside Wisteria Cottage, the drain that leaks outside Braddon Cottage and will report it to Southwest Water. We think this is the one that Southwest Water was going to sort out with road closure but failed to do so.

We mentioned the Youldon Moor Cross being a dangerous intersection. SB was aware of the recent tragic accident. We also mentioned Solden Cross as a hazard. Although out of our area but used by the residents of Bradworthy.

SB was going to check that the de-restriction signs on North Road had been moved back to their original spot. Moving de-restriction signs incur costs because it must go through a legal process.

We mentioned Chapter 8 training and SB said she would send some details. We asked if it would be helpful if parishes joined forces. SB said she thought it might be but was unaware if any parishes have done this.

SB said that unless we had any areas that required the enforcement officer to check on, then MC said she would speak to CLT for a date for the AGM
