the property with the scaffolding to get end caps fitted to the scaffolding that overhangs into the play area, the damaged boundary fencing does not belong to the Parish Council and is therefore the responsibility of the home owners.

13. Apple Trees

Cllr Payne had contacted Adams Apples who advised the best apple trees for the village for this position = Limberland, Tidcombe Seedling and Oaken Pin. Cllr Payne had emailed all the information to the Council prior to the meeting. It was discussed and agreed that these should be purchased and to also purchase guards, stakes and ties. proposed SP seconded VC all agreed

We have checked with DALC about this group linked to the Parish Council regarding bank account, this needs to be run as a subcommittee/working party for the Parish Council agendas and minutes will need to be kept and any decisions will be made by the Parish Council and any grants will need to be applied for by the Parish Council.
