## Adopted Minutes of BRADWORTHY PARISH COUNCIL meeting held in the Collacott Room, Bradworthy Memorial Hall on Friday 23<sup>rd</sup> January 2026 at 7pm

District Cllr S Andrews, Clerk Chris Summerfield and 1 member of the public

Cllr Lander advised that the meeting is being recorded

Some areas are more damaged than previous months, Cllr SP feels there needs to be a sub  
group so that jobs are being done. Piran to take on the checking every 3 months, does it need to  
be checked in between. CS to check with Piran re costs and for them to be doing repairs after  
approval. Maintenance person to check in between.

### 17. Grant

No applications have been received yet but the deadline is February

Cllr GG explained that there is a need to update the event lighting for a new system this will cost  
approximately £3000 and so it was discussed if BPC should apply for a grant from Forestmoor. A  
discussion was held about the Forestmoor money in the account, we receive £3000 a year at  
the moment. If the 2025 £3000 receipt hasn't been transferred into the Forestmoor account

from the current account this will give a total of £24k CS to check and transfer if needed. Cllr SP explained that the Parish Council are able to use Forestmoor funds for purchases like this if it is to benefit the Parish in general, it was felt by most that the event lighting did benefit the Parish. Suggested that Parishioners should be asked at the coffee morning for ideas.

Then a further discussion from these suggestions should be had.

Cllr LH commented that this money would not continue long term and once someone has applied once for money they feel they can't apply again

#### **18. Flowerbeds/Boxes**

The issues with plants not growing well under the trees in the square was discussed, it was agreed that further research into what plants might be able to survive MC had previously spoken to someone who might be able to help with this. Cllr Lander thanked all those who had looked after the flower boxes.

Chris suggested that we should ask District Cllrs for any grants available for plants this year District Cllr Andrews said she would be happy to offer £200 subject to putting in a formal application and she would ask Cllr Dart.

#### **19. Bench on the Green**

Cllr SP suggested that this need replacing with a bench similar to the one in the play area but will need anchoring down **CS to find prices**

#### **20. Newsletter**

SP was keen to have a newsletter it was discussed but decided that Bradworthy News/FB/Noticeboard would be better way forward

GG proposed that the maintenance duties should also be put out for tender each year seconded VC all agreed (the duties to be confirmed – changes to the play area checks as Piran will be asked to do the official checks so that we don't need to ROSPA train someone each time there is a change of maintenance person)
