5.06 Chairmans Report

I received an email from South Western Ambulance Service concerning the defibs at the football club and Seiche.

As from 17th June 2027 South Western Ambulance Service are no longer offering or supplying defibrillators and cabinets and therefore unable to provide defib packages.

There are 2 options available to us for the equipment we have when the contract ends.

1. We can return the equipment at the end of the term or
2. We may be formally gifted and take full ownership of the equipment if we can meet the following criteria.

- The organisation must be named as the new owner and take responsibility for the equipment. A representative with appropriate authority must sign a formal gifting letter

- The equipment will no longer be owned by South Western Ambulance Service
- The equipment is no longer in warranty by the manufacturer.
- The Parish Council will be the owner of the equipment and will be fully responsible for any further needs, updates, repairs and replacements.
- SWASFT will not provide training, pads or batteries moving forward.
- If we wish to keep the defib registered on the 999 system to be allocated in an emergency, we will need to go on line and 'claim' our defibs on The Circuit and arrange for a suitable guardian to regularly inspect and report on them, which is what we do now.

I have planted up the remaining flower beds in the Square. We have made a start on the Millennium Garden and I will be buying plants to fill it next week.

6.06 Clerks Report

I have reported a number of street lights that were out of action – these were repaired very quickly
 We have received a thanks from North Devon Record Office regarding the grant
 Donation from Bradworthy Carnival £150 which they have asked if we could use it on the play area, this cheque has just been banked
 Play Inspection booked but awaiting date
 Report from concerned Parishioner regarding electric bikes and scooters – I am unable to respond as no contact details. This is a difficult one but BPC are unable to do anything.
 More road closures being notified so I have added them to our website.
 External Audit information has been sent but due to EE problems in the area this has been more difficult to send.

Internal Scrutiny meeting – planning enforcement officer reported that they have caught up
 Food Safety Service reported 800 food businesses mostly good 3 star or above
 National Landscape Meeting – there is a £68k grant available. Strategy has been set
 Climate Emergency working group – debate about spending money on biofuel vehicles.
 Biosphere meeting – Smart rivers – people involved taking samples. We have talked to the water authority and environmental agency. So many houses having septic tanks that don't work properly leaking into the system, it is all about education
 I missed the AGM but everything remains the same
 There needs to be a number of reservoirs
 NDDH residential housing £22.7m and the staff car park will be built on
 Bideford to be diagnostic centre
 The road between Whitely and Bradworthy has had some work done
